Prior to this, Ms. Rieben was an associate at one of the largest family law firms in Connecticut. Earlier in her career, she worked as a Staff Attorney at Legal Services of the Hudson Valley, in the organization's domestic violence unit. Additionally, she was a Staff Attorney at the Center for Family Representation, Inc., where she represented parents in child protective proceedings in New York County Family Court.

Ms. Rieben earned her Juris Doctorate from New York Law School and her Bachelor of Arts Degree, Magna Cum Laude, from Colby College. Additionally, she was a general course student at the London School of Economics. Ms. Rieben is admitted to practice in the States of New York and Connecticut.

She currently serves as Vice President of the Women's Bar Association of the State of New York ("WBASNY"). She is a Past-President of the Westchester Women's Bar Association (the "WWBA"), a recognized chapter of WBASNY. Ms. Rieben has also served as State Director, President Elect and Recording Secretary of the WWBA.
